### **Department History and Development**

The offcampus degree program was developed in the early 1970s. It was the result of inquiry from professionals within the Seventh-day Adventist organization who desired public health and preventive medicine concepts they could use to enhance their professional services to the public. In the fall of 1973 the School of Health responded with a pilot program in the Canadian province of Alberta. An average of 25 students from the prairie provinces pursued coursework so that 18 students were granted the M.P.H. degree in the fall of 1978.

The success of the offcampus degree program in Alberta gave impetus to beginning a second degree program. In the summer of 1975 the North Pacific Union Conference of Seventh-day Adventists cosponsored an offcampus program serving the states of Washington, Oregon, Idaho, and Montana. An average of 60 students attended the courses offered, and in the fall of 1979 52 students were granted the M.P.H. degree.

The offcampus degree program continued to develop and grow in numbers of centers and students. Presently the Office of Extended Programs directs 10 teaching centers in the United States and Canada, with approximately 275 students taking coursework toward the M.P.H. degree.

Effective April 1, 1981, the Office of Extended Programs assumed administrative responsibility for the Inter-American offcampus degree program. The M.S.P.H. degree program is presently operating at 4 centers, with approximately 150 students taking coursework.

The School of Health was established by the Seventh-day Adventist church for the purpose of educating people in concepts of true health. The church believes that true health encompasses health of body, mind, and soul. It believes that true education leads to the harmonious development of all these aspects of man, and that all can achieve true health through true education.

Recognizing an obligation to promote an understanding of true health to all, the School of Health seeks to develop a larger and more comprehensive educational outreach program. In keeping with this obligation, the Office of Extended Programs was instituted.

Through the Office of Extended Programs, the true health concepts studied at the School of Health are made available to individuals in cosponsorship with the union or conference level of administration in the Seventh-day Adventist church throughout North America. Because of employment and family responsibilities, these individuals are unable to arrange for time off to pursue full-time academic and professional study programs. However, they still desire health and preventive medicine concepts for the continued enhancement not only of their own health but also for the improvement of health in individuals met in their professional contacts. To accommodate and serve these people, the offcampus M.P.H. degree program continues to be offered.
